- A subcommittee of the national committee will review all applications, and present a selection to the National Committee to go forward to the Annual Meeting. Appointments are made at the Annual meeting, and an election may be held if there are more approved candidates than places.
- Central to our procedure is building a balanced diverse committee, with diverse representation across companies, sectors, experience, expertise, profile, background, etc, and avoidance of any conflict of interest.
- The initial appointment will be for a two year period.
- Only members who join the virtual Annual Meeting on **27 September 2023** will be entitled to vote.
